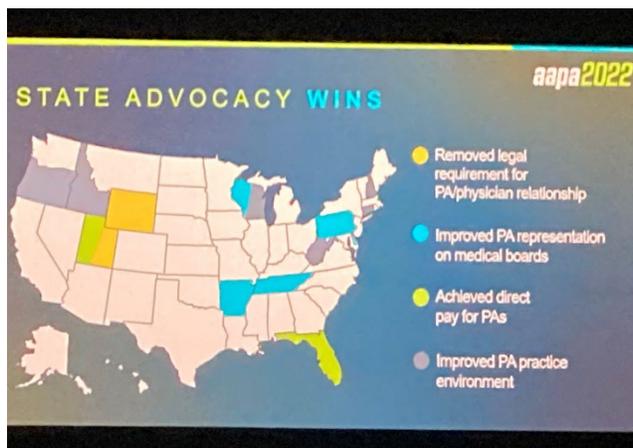

HOD Update from AAPA

This was my first in-person HOD meeting. This meeting was very insightful and motivating. I really enjoyed the passion of the AAPA delegates from all states, territories, and constituent organizations.



The opening session included a National Color Guard and the National Anthem paying homage to the beginnings of our profession. The first day focused on policy and new business. There was an overview of the states which have had huge advocacy wins to move the Physician Associate Profession forward. This speaks to PA's in some states granted the same autonomy as NP's. This was an example of AAPA state chapters and AAPA PAC (political action committee at work).

Fortunately, I was seated next to Jonathon Baker PA and President of the New York Delegation. He guided me through the proceedings and encouraged that I share opinions of Endo PA's when appropriate, more on this later. There was much discussion on the adoption of the name Physician Associate and that we should all embrace this title collaboratively. It was suggested that names of affiliated organizations should reflect the name change.

Within the body of one policy there was reference to "APP's" referring to Physician Associates and Nurse Practitioner's together. The grouping of APP's can include non-prescribing clinicians such as physical therapists and pharmacists. The reference as APP's can lead nonclinical administrators to inappropriately categorize PA's in policy and contracts. We should encourage that APP's not be used and that we should recognize healthcare professionals by their correct title. We need to get behind the Physician Associate name and

promote our brand and what we bring to the healthcare systems as truly a needed part of the healthcare team.

One policy change which generated much discussion on both sides was a change in policy to allow HOD Student delegates the ability to vote in AAPA elections for officers. The “cons” noted that the students have not completed their training and have not passed their boards, so they should not be allowed a vote. It was also noted that program directors could guide decision making for their student delegates. The “pros” noted that we need to foster leadership and inclusion among student delegates to encourage their engagement in AAPA and develop leadership skills. Of note there were approximately 300 PA delegates and 31 PA Student delegates. The student delegates expressed much passion about the ability to vote for officers as their leaders. Several members had a moment at the microphone and stated, “Let them Vote!”. In the end after about 2 hours of structured debate, the student delegates were granted authority to vote for officers for AAPA. I hope you will join me in welcoming this change to the AAPA and HOD.

There was policy debate on the “Terminal Degree” for PA’s. Policy noted that the terminal degree as a Master’s Degree. This generated much debate on the terminal degree being a Doctorate. The “pros” for the Doctorate noted that often this is needed to obtain tenure at certain PA Training Programs affiliated with universities. The “cons” noted that if our policy recommends a Doctorate this could become a barrier to some PA’s obtaining positions as a doctorate noted as the terminal degree could limit opportunities for PA’s. After much debate on this issue, the HOD voted to continue with the terminal degree as the Master’s.

Policy was changed to reflect CDC recommendations for COVID-19 vaccinations based on CDC guidelines for age, recognizing this language needed to be fluid per changes in vaccinations and knowledge of COVID-19 virus/illness.

There was a policy recommendation to encourage PA training programs to provide basic understanding and competence in telemedicine. This was objected to by several PA’s in educational programs as they noted they did not have the time nor bandwidth to understand EMR and intricacies of Telemedicine. I then went to the mic, patiently awaited my turn and spoke to the fact Telemedicine is here to stay. During the Pandemic I moved my clinic to 90% telemedicine to keep patients, clinicians, and staff safe. I noted that very robust and meaningful visits are continuing to take place virtually. I asked the policy to be written in such that AAPA recommends PA Training Programs provide basic competence on Telemedicine requirements and examples of phone and virtual health visits so that this isn’t completely new to the PA graduate. In the end, it was recommended that PA Training Programs should provide basic understanding and competence of telemedicine.

These are just a few examples of what was discussed at AAPA HOD 2022. Now, I ask each of you to try and become involved in your state PA Organization and consider being a member of your state AAPA HOD. Of note, when attending HOD your conference attendance fee is covered (hopefully, this will continue). We need to collectively self-promote the Physician

Associate Profession. During the Pandemic it has been made very evident the need for nursing. The nurse shortage has been in the headlines many times. The Nursing and NP organizations are capitalizing on this and their ability in many states to practice independently. We need to legislate at our local state levels for PA's and NP's to practice in par. We need to collaborate and gain the support of Physicians and AMA on this issue focusing on our similarities in training and practice model. It is important for ASEPA to have a seat on the HOD to represent the unique and needed role that endocrine PA's fill for patients.

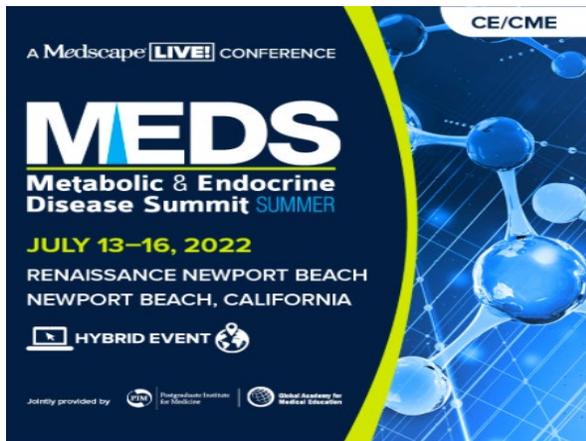

The four-day conference was filled with many interesting lectures from endocrinologists all over the world and multiple plenary sessions and debates on hot-topics such as evolution of type 1 diabetes treatment, treatment of adrenal nodules, drivers of the "PCOS" bus, and transgender/intersex athletes.

As my personal interest is in pituitary/adrenal disease and transgender health, most lectures I attended were on those topics. My favorites were on dilemmas in management of pituitary tumors, management of recurrent non-functioning pituitary adenomas, multiple highlights of how we need to be better about screening for primary hyperaldosteronism, and the transgender health talks. Although my inpatient diabetes provider time is ending soon as I transition to part-time faculty at the Mayo PA Program, I also greatly enjoyed the lecture on management of Type 2 Diabetes in folks with CKD, as the data is overwhelmingly positive. Hopefully when I have time (haha!), I will watch a few of the lectures I missed online.
